- Vance-Granville Community College acknowledges the College signed and returned to the Department of Education (Department) the College's Certification and Agreement for Emergency Financial Aid Grants to Students under the American Rescue Plan (ARP) Act. This includes assurance that the College has used, or intends to use, the applicable amount of funds designated under ARP Section 18004(a)(1) of the ARP Act to provide Emergency Financial Aid Grants to students.
- The College was funded \$2,589,405.00 from the Department pursuant to the College's Certification of Agreement for Emergency Financial Aid Grants to Students.
- As of the date of this report, the College distributed \$2,589,405 to students.
- The estimated total number of the College's students eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act is 2469.
- As of the date of this report, the total number of students who received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Acts is 2469.
- The methods used by the College to determine which students receive Emergency Financial Aid Grants, including how much a student would receive under Section 18004(a)
(1) of the CARES Act have been determined. See Exhibit 1.
- Students who are eligible to receive an Emergency Financial Aid Grant received an email notification (Exhibit 2) and given the option to apply the funds to their account (Exhibit 3).

EXHIBIT 1

Vance-Granville Community College Coronavirus Aid, Relief, and Economic Security (CARES) Act Federal Higher Education Emergency Relief Fund Emergency Financial Aid Grants to Students Eligibility Determination Guidelines

Eligibility Criteria:

- An eligible student must have a 2021-2022 FAFSA on file and meet the following Title IV eligibility criteria defined by Sec. 484 of the HEA:
 - Be enrolled in a curriculum program.
 - Not be enrolled in elementary or secondary school.
 - For currently enrolled students, be making satisfactory academic progress.
 - Not owe an overpayment on Title IV grants or loans.
 - Not be in default on a Title IV loan.
 - File “as part of the original financial aid application process” a certification that includes
 - i. Student’s SSN.
 - ii. Cleared any outstanding verification items
 - Be a U.S. citizen or national, permanent resident, or other eligible noncitizen.
 - Have returned fraudulently obtained Title IV funds if convicted of or pled guilty or no contest to charges.
 - Not have fraudulently received Title IV loans in excess of annual or aggregate limits.
 - Have repaid Title IV loan amounts in excess of annual or aggregate limits if obtained inadvertently.
 - Have Social Security Number verified.
- New or returning students must be enrolled in curriculum courses for the Summer 2022 semester.
- Furthermore, awarded amounts will be prorated based on the student’s enrollment status for the appropriate semester as follows:
 - Pell Eligible - \$800
 - Non-Pell Eligible - \$400

The American Rescue Plan are funds provided to Vance-Granville Community College that are to be used for students. Any student who has completed high school and enrolls and attends a 2022 Summer curriculum course is eligible. Students who are eligible the Federal Pell Grant will be eligible for \$800. Students who are not eligible the Federal Pell Grant will be eligible for \$400.

The American Rescue Plan allows Vance-Granville Community College, with your permission, to apply the funds directly to your account. When funds are applied directly to your account, they will be applied to your tuition and fees. Any outstanding balance, is the student's responsibility, if the grant is larger than the tuition and fees, the remaining amount can be used in the bookstore. If the remaining amount is not spent in the bookstore or you choose to not purchase books with it, it will be sent to you in the first refund period assuming you have participated in Summer 2022 Courses.

The deadline to complete this is: Thursday, May 19 by 5 pm.

If you are interested in having these funds applied to your account for this purpose, you **MUST** complete the fund authorization and choose the option for the school to apply to your account. The authorization can be completed at [this link](#). You must log in with your MYVCC credentials to access the form.

If you enroll and participate in Summer courses and do not want this fund applied to your account, no action from you is needed. You will still qualify; however, the fund will be sent in full to you after the term begins near the same time as the first refund disbursement. You will be responsible for tuition, fees and books through either personal payments or other means of financial aid.

As with all grants, this does not need to be repaid. In addition, this does not need to be claimed as income on taxes per guidance from the IRS and Department of Education.

Please note that this fund can only be used in Summer of 2022. It cannot be rolled into another term.
